Northeast Racing Products 2018 Rules and Regulations For Exhibitors

Move-In and Set-up

- -Exhibitor spaces will be available for set-up from 8am until 8pm on Thursday, November 15. Move-in hours will be strictly enforced for security purposes. **ALL EXHIBITORS MUST BE SET UP PRIOR TO 8PM, THURSDAY, November 15TH. NO EXHIBITORS WILL BE ALLOWED TO SET UP AFTER 8PM, THURSDAY. NO EXCEPTIONS!** *Special arrangements for early arrival can be made by calling the Northeast Racing Products at 315-374-2839.
- -Parking/gate passes and exhibitor credentials will be issued at the exhibit reigistration building located inside the Center of Progress Building. Registration will be manned Thursday, November 15 from 8am until 8pm. Each exhibitor will be issued one (1) on grounds parking pass (THESE VEHICLES MUST BE PARKED IN DESIGNATED VENDOR PARKING AREAS ONLY. PLEASE NOTE: Non-Display vehicles will not be allowed to park in or around display areas.)
- -Vendor Gate Passes: 2 passes per 10x10 booth

Additional weekend vendor passes may be purchased at \$10 each.

- -Indoor exhibitor fee covers space as well as pipe, drape and 110v electricty. On-site contracted exhibitor decoration services will be provided by **Northeast Decorating & Exhibit Services, Inc., P.O. Box 607, Syracuse, NY 13209**. - -Exhibitors requiring more than basic 110v electrical service will be charged a fee. Please contact Northeast Racing Products staff at (315) 374-2839 as early as possible if a need for such services is anticipated.
- -Exhibitor display and merchandise must remain within the confines of the contracted space. Exhibit materials must not overflow into the aisles. Distribution of literature and sales aids must take place within your assigned vendor space ONLY.
- -Booth space must be used solely by the company/person and for the products and services stipulated in the rental agreement. Subletting of space by exhibitors is strictly prohibited.
- -Exhibitors are required to maintain a neat and orderly appearance at all times.
